

## CITY OF CHICAGO DEPARTMENT OF PUBLIC HEALTH RECORDKEEPING REQUIREMENTS FOR RECYCLERS



In 2008, the City passed the Prohibited and Regulated Materials Ordinance, Section 11-4-2625 of the Chicago Municipal Code. Updated in 2014, the Rules and Regulations for Recycling Facilities require operators to keep records of transactions involving any of the materials listed below. This flyer is for general information only. It is not intended to replace, interpret, or modify any federal, state, local, or other law of any kind, nor does it provide or constitute legal advice.

Stop signs & other street signs	Metal fencing & gates
Utility hole covers, including sewer lids, "manhole covers" & grates	Metal downspouts & gutters
Fire hydrant parts, including caps & nozzles	Metal siding & doors, including siding from homes & garages
Water meters & parts of water meters including meter lids	Metal door hardware, including knobs, hinges & kick plates
Gas meters & parts of gas meters	Metal sinks
Electric meters & parts of electric meters	Aluminum wire
Exterior telephone wire	Copper wire
Transformers	Copper pipes
Metal street lamp posts, sign posts, & flag poles	Metal coils
City street lights, including viaduct lights	Copper/aluminum radiators & auto radiators
Any other material of the type typically owned or maintained by a governmental entity or a utility company	License plates
Cemetery urns & plaques	Barbeque grills
Historical markers	Metal patio furniture
Metal sculpture & statuary	Satellite dishes
Tree grates & flower grates	Metal exterior light fixtures
Beer kegs	Boilers, furnaces, water heaters, & any parts thereof

You must tell the scale operator if your load includes any tanks like these.

We will pay you for them, but we MUST separate these tanks from the rest of your load. Failure to comply will result in penalties, we thank you for your cooperation.



As you know, some recyclable materials can pose a threat to human health and/or the environment if not recycled or disposed of properly. As such, the following materials <u>MAY</u> be accepted at Windy City Iron & Metal, but <u>ONLY IF</u> it is determined that such materials can be handled and disposed of in accordance with applicable federal, state and local rules and regulations.

## Flammable/Combustible Materials

Any scrap material that may have contained potential flammable or combustible materials must be segregated from all loads delivered to Windy City Iron & Metal (See examples below).



## Potential Fire Hazards

- Any scrap material that has the potential to cause a fire must be segregated from all loads delivered to Windy City Iron & Metal (See examples below).



## **Compressed Gas Cyliners**

- Intact compressed gas cylinders must be segregated from all loads delivered to Windy City Iron & Metal (See examples below).






## **Ballasts and capacitors**

- PCB ballasts and capacitors must be segregated from all loads delivered to Windy City Iron & Metal (See examples below).










## Hazardous Materials

## The following materials must be segregated from all loads delivered to Windy City Iron & Metal:

- Mercury containing materials (i.e. thermostats, thermometers, baumanometers, switches, fluorescent or mercury vapor lights, etc.).







- Asbestos-containing materials (i.e. pipe insulation, surfacing materials, etc.).







- Aerosol cans that are not punctured and empty.







## **Electronics**

- The following items will only be accepted incidentally since Windy City Iron & Metal is not a registered Electronics Recycler and we do not process these items:
- Televisions of any kind including CRT, plasma, LCD, LED
- Computer Monitors
- Computers and Small-Scale Servers
- Electronic Keyboards & Mice
- Printers, Fax Machines, and Scanners
- DVD Players, DVD Recorders, and VCRs
- Digital Converter Boxes, Cable Receivers, and Satellite Receivers
- Portable Digital Music Players and Video Game Consoles







## <u>Appliances</u>

 Appliances containing refrigerants will be accepted but <u>only</u> if supplier provides notification in accordance with the Windy City Iron & Metal Refrigerant Recovery Contract, which will allow Windy City Iron & Metal the opportunity to properly recover any remaining refrigerant from the appliance.



## **Closed Containers**

 Any container (tank, drum, etc.) that is sealed and/or cannot be inspected for interior contents will <u>NOT</u> be accepted under <u>ANY</u> circumstances.
